I agree that if I suffers personal injury that I will hold harmless Stephanie Koch, Judy McHerron, Lisa Lombardi, Maxine Freitas, Joyce Torrigino, Diana Thompson, their family, Sonoma County Junior College District, SRJC Shone Farm and its affiliates.
